The Business Operations Committee of Upper Grand District School Board met on Tuesday, September 12, 2017, in the Board Room at 500 Victoria Road North, Guelph, Ontario commencing at 7:00 p.m.

The Chairperson, Trustee Schieck presided, and the following Trustees were present: Bailey, Busuttil, Cooper, Fairbairn, Lustgarten Evoy, MacNeil, Moziar, Topping, and White, along with Student Trustees Caitlin Ennis and Allison Cai.

Present from the Administration were, Director of Education Rogers, together with Superintendents Heaslip, Lindsay, McDonald, Morrell, Regier, Slater, and Van Ooteghem, Communications Officer Loney, Executive Officer of Human Resources Rose, Student Success Lead Zen, Manager of Planning Passy, Senior Planner Imm, Operations Officer Scinocca, and Manager of Operations Veit.

# West Guelph French Immersion (FI) Boundary Review – Final Boundary Review Report

Senior Planner Imm presented the final FI boundary review report for West Guelph. She reported that, after reviewing all the input received, the committee discussed and considered alternatives and determined that it continued to recommend Option 3 as outlined in the Final Boundary Review Report.

The boundary changes proposed in Option 3 included:

Trustees expressed thanks for the report. Questions were raised with regard to how children, families, and schools would be impacted. Trustee Busuttil raised a concern about the gradual growth of the program, and how it may impact the strength of the program. She stated that she could not support Option 3, and suggested that Option 4 be brought back to the table as a viable option for a stronger program. Trustee Bailey noted that the vast majority of FI programs started as multi school programs, and that there was an overwhelming public feedback that favoured Option 3, which he also supported.

#### Recommendation #1

Trustee Moziar moved that:

- The memo PLN: 17-21 "West Guelph French Immersion (FI) Boundary Review – Final Boundary Review Report" be received.
- 2. Further to confirmation in Memo 2017-003 "The 2018-19 New French Immersion Program Location, Grade Structure and JK Enrolment Cap Report" establishing an enrolment cap of 29 JK FI students at Gateway Drive PS, the Board approve the following differentially applied school level enrolment caps effective September 2018:
  - a) 29 JK FI students at Paisley Road PS
  - b) 58 JK FI students at John McCrae PS
- 3. The Board approve Option 3 as described in Section 5.0 in the report attached to memo PLN: 17-21 "West Guelph French Immersion (FI) Boundary Review Final Boundary Review Report", effective September 2018.
- 4. That the Board approve the attendance area boundary maps which implement Option 3, as follows:

- a) the JK-3 FI attendance area boundary for Gateway Drive PS as outlined on Map 1 of Appendix A,
- b) the Grade 4-8 FI attendance area boundary for Willow Rosd PS as shown on Map 2 of Appendix A,
- c) the JK-6 FI attendance area boundary for Paisley Road PS as shown on Map 3 of Appendix A,
- d) the JK-6 FI attendance area boundary for John McCrae PS as shown on Map 4 of Appendix A, and
- e) the 7-8 FI attendance area boundary for John McCrae PS as shown on Map 5 of Appendix A.
- 5. The implementation timelines applicable to FI boundary changes in Option 3 be approved as follows:
  - a) Effective in September 2018 JK and SK FI students who reside within the new Gateway Drive PS JK-3 FI boundary are reassigned from Paisley Road PS to Gateway Dr PS,
  - b) Effective in September 2018 all Grades 1-8 FI students who reside within new Gateway Drive PS JK-3 FI and Willow Road PS Grades 4-8 FI boundary will be grandparented at Paisley Road PS/John McCrae PS until the end of Grade 8,
  - Effective in September 2018 JK-4 FI students who reside within the new Paisley Road PS JK-6 FI boundary will attend Paisley Road PS,
  - d) Effective in September 2018 Grades 5 and 6 FI students who reside within the new Paisley Road PS JK-6 boundary will be grandparented at John McCrae PS,
  - e) Effective in September 2019 Gateway Drive PS will accommodate JK-1 FI,
  - f) Effective in September 2019 JK-5 FI students who reside within the new Paisley Road PS JK-6 FI boundary will attend Paisley Road PS,

- g) Effective in September 2019 Grade 6 FI students who reside within the new Paisley Road PS JK-6 FI boundary will be grandparented at John McCrae PS,
- h) Effective in September 2020 Gateway Drive PS will accommodate JK-2 FI,
- i) Effective in September 2020 JK-6 FI students who reside within the new Paisley Road PS JK-6 FI boundary will attend Paisley Road PS,
- j) Effective September 2021 Gateway Drive PS will accommodate JK-3 FI,
- k) Effective September 2022 Gateway Drive PS will accommodate JK-4 FI,
- Effective September 2023 Gateway Drive PS will accommodate JK-3 FI,
- m) Effective September 2023 Willow Road PS will accommodate grades 4-5 FI feeding from Gateway Drive PS. Willow Road PS will continue to grow by a grade each year to accommodate grades 4-8 FI by 2026/27.
- 6. The Board allocate funds to support the accommodation of JK-3 FI at Gateway Drive PS, specifically for two (2) additional FDK classrooms,
- 7. The Board allocate funds to support the acquisition of additional French Immersion resources to expand French Immersion instruction at Gateway Drive PS and Willow Road PS.
- 8. The Board direct staff to convene a Transition Planning Team to work with the school communities in developing and implementing plans at Paisley Road PS, John McCrae PS, Gateway Drive PS and Willow Road PS to address students, materials, etc., prior to the end of the 2017/18 school year.

A recorded vote was requested.

## **2017 Facility Partnership Report**

- 2. The Board advise those on the Partnership List that there are no partnership opportunities or suitable surplus spaces available at this time in existing facilities.
- 3. Staff be directed to consult the Partnership List regarding interest in cobuild opportunities at possible future schools in Fergus and South Guelph.

## **Erin Sports Field Recommendation**

Manager of Plant Operations Veit presented plans for the redevelopment of the track, field and play spaces at Erin PS. He reported that high school and elementary school communities were consulted and support the location of Erin PS for the proposed project. Field feasibility, risk assessment, field alternatives, community engagement, public open house, timing of sports activities, construction detail, and proposed concept were discussed in detail. Trustee Cooper expressed her excitement and gratitude to staff for the extraordinary amount of work for the community of Erin. She noted that the completion of the Erin Sports Field will serve the needs of both Erin PS and Erin DHS and that the project was also supported by the community.
