Long Term Accommodation Plan (LTAP) Background Report and Public Engagement Plan

The LongTerm Accommodation Plan (LTAP) is a strategic review of the school board's facilities, population projections, and enrolment forecasts. The LTAP is an important step in ensuring alignment of school facilities with the needs of the Board and the communities it serves.

The information contained in the LTAP will make it clear where there are changes in accommodation needs, now and into the future. A long-term plan is needed as changes to school facilities, such as new construction, take time to plan and execute.

The goal of the LTAP process is to produce a list of priority areas for the Board to concentrate on in the short and long term. On a regular basis, the Board will update the analysis to confirm that the list of priorities match the needs of the Board.

Superintendent of Finance Regier summarized the details of the LTAP package, and noted that the presentation would cover the LTAP key milestones, a walkthrough of the key components of the background report, and an overview of the communication plan. Manager of Planning Passy presented the Long Term Accommodation Plan Background Report in great detail. She outlined the process and timeline, the public engagement plan, and the communication plan. There are five regional Public Engagement Workshops for the Background Report, which are scheduled for:

- Thursday, February 8, 2018, Orangeville DSS, cafetorium
- Monday, February 12, 2018, Centennial CVI, cafeteria
- Tuesday, February 20, 2018, Norwell DSS, single gymnasium
- Wednesday, February 21, 2018, Centre Wellington DHS, cafetorium
- Wednesday, February 28, 2018, Erin PS, gymnasium

Manager of Planning Passy advised that, after the public engagement workshops, a summary of input would be presented to the Board and would inform the preparation of a draft LTAP. The draft LTAP will be shared through a second phase of public engagement before a final LTAP is presented to the Board in June 2018. Trustees expressed many thanks for a very comprehensive and thorough report.
