Our thanks to Directors Rogers and Sovran, along with the Senior Administration team for their outstanding guidance for the system throughout this past year as well as their support of the work of the trustees.

Last but definitely not least, thank you to my fellow trustees for everything you have done this past year. We have continued to learn new ways to do our jobs and support the families and communities in the Upper Grand DSB. The leadership you have shown has been immeasurable and does not go unnoticed.

It is with great pride that I look back on my time as Chair of the Board in 2021, and, on behalf of the Board of Trustees, I share our deepest gratitude to everyone for your commitment and hard work during these challenging times. Our dedication to inclusion has created a culture of caring and it is an honour to do this work alongside all of you.

Wendy Donaldson currently serves as the Upper Grand DSB's Assistant to the Superintendent of Program Services, with primary responsibilities for Special Education, Kindergarten to Grade 12, and will assume the role of Superintendent of Education on April 1, 2022 replacing Superintendent of Program Tracey Lindsay who is retiring this spring.
