# Upper Grand District School Board Board Meeting Tuesday, April 26, 2022 Minutes

The regular monthly meeting of the Upper Grand District School Board was held virtually and in person on Tuesday, April 26, 2022, in the Board Room at 500 Victoria Road North, Guelph, starting at 7:00 p.m. All Trustees were present with regrets from Trustee Bedi. # 2. Opening Prayer / Reading – Trustee Foley

Trustee Foley spoke about what it means to be part of a community and how everyone can do better as Community members working towards common goals.

### 4. Good News/Director's Report

Director of Education Sovran provided some reflections, highlights and good news items that took place in Upper Grand DSB during the month of April.

Director Sovran's school visits in April highlighted the incredible work being done each day to support student learning experiences, and the visits showed him how we are all stronger together.

### International Day of Pink

On April 13, schools celebrated the International Day of Pink. The International Day of Pink is a worldwide anti-bullying, anti-homophobia, and anti-transphobia event. Since the International Day of Pink's inception, students and schools have taken up the mantle of recognizing this day's purpose: to create a more inclusive and diverse global society, by encouraging young people to challenge social norms, to ask more of their educators and school systems, and to stand up against bullying toward their

# Annual H2Awesome water conference wraps-up on Earth Day

All month, Upper Grand intermediate students had the chance to think critically about the importance of water, as part of the "H2Awesome" water conference. The annual event is a celebration of water and allows grade 7 and 8 students to learn about the importance of water and water conservation. This year, more than 1,000 Upper Grand students took part in the various events at the conference, which was held over a five-week period beginning March 22. The conference was intentionally planned to begin on World Water Day and end on Earth Day to help students to spend an extended amount of time focused on environmental learning. Overall, there were 14 speakers over the month, including two presentations in French.

### 10. Wellington-Dufferin-Guelph Public Health Presentation – Dr. Tenenbaum

Dr. Tenenbaum, Wellington-Dufferin-Guelph Public Health's Associate Medical Officer of Health, presented an update on the current COVID-19 situation in our community, and changes that have happened in the past month.

Dr. Tenenbaum shared updates on the following: the community currently in 6<sup>th</sup> wave of the pandemic; increased case numbers; high community risk and maintaining measures known to reduce the risk of COVID-19; the importance of vaccination; and being mindful of the three C's – thinking about closed spaces, crowded spaces, and close contact scenarios.

Dr. Tenenbaum reported the need to be extra careful in scenarios where COVID-19 transmits most easily and being extra thoughtful about wearing a good fitted mask, physical distancing, and limiting the size of gatherings. He stated the more chances there are to incorporate these practices, the more that will be done to reduce the risk of COVID-19 in the community.

Trustees asked questions of clarification and thanks were expressed to Dr. Tenenbaum, for his presentation and for his time to attend the meeting and to answer questions.

# 18. Monthly COVID-19 Update

Executive Superintendent McDonald shared some updates on Upper Grand DSB's continued response to the impact of COVID-19 in Upper Grand schools. Since the last board meeting in March, absenteeism, and the prevalence of COVID-19 in the schools mirrored what was happening across the community. There was a peak in the majority of schools in early April, but over the past two weeks there has been a slow, steady decline in absenteeism rates both amongst students and staff.

A summary of measures which continue to be employed in schools were provided and Mr. McDonald highlighted a renewed emphasis on asking staff and students to wear masks as recommended by Public Health, both locally and provincially.

An overview of 3 key areas were provided:

### 1. COVID-19 Health and Safety Guidance

- Protective Measures Campaign
  - o Common message from Board and Union partners
  - Request to wear masks indoors
  - Poster campaigns and visual reminders
  - Classroom education materials
  - All protective measures continuing
- Screening and Verification continuing

## 2. Absenteeism Reporting and Updates

- New COVID-19 Self-Reporting Data
  - Provide a regular report of positive COVID-19 cases that were self-reported to the school
  - Provided for a short time period to respond to increasing case counts in the community
  - The self-reported cases will show on their school website the date it was updated, and the number of cases that were selfreported to the school on that date
- Recent Absenteeism Data
  - Daily absent tracking pilot continues
  - Allows to monitor trends in absenteeism rates and gives a better sense of the impact of COVID-19 on schools
  - Generally absences are now trending down after peaking in early April

### 3. <u>Elementary and Secondary Updates</u>

- Mental Health Supports
  - Continue to be both proactive and responsive in approach to support student, staff, and families
  - Continue to provide direct support for students from JK-12 relating to Mental Health and Wellbeing through in school mental health professionals specialized supports
  - Provide opportunities for direct modeling as well as targeted and intentional learning opportunities most notably through the Wellness Works Project
  - Regularly monitoring newly emerging data relating to COVID-19 impacts on children, youth and family mental health and wellbeing

- Parent webinars series is continued partnered with Compass to Design on how to know if your child is struggling and strategies to support
- Continued collaboration with community partners around trends, gaps, and sharing of resources to ensure that support systems and pathways focus on the current needs of students and families

Trustees asked questions and expressed thanks for the update.

**RESOLUTION #22-115**: Trustee Foley moved that the verbal monthly COVID-19 update be received with thanks.

### 19. Multi-Year Plan Update

Director of Education Sovran provided an update on the Multi-Year Plan. Through a board resolution #22-08 dated January 11, 2022, which was approved at the January 25<sup>th</sup> board meeting, initiated the Upper Grand Multi-Year Plan Process. Director Sovran shared a diagram of the MYP process and milestones, and he noted one adjustment to the process in the month of April, which is a second session for the trustees which will happen tomorrow on April 27<sup>th</sup>. Following that session, a draft vision and priorities will be brought forward to the next board meeting at the end of May. Before the May board meeting, the engagement process with students, families, and community members will begin gathering their voice around the draft of the vision as well as the priorities. Director Sovran expressed thanks to trustees for their work in undertaking the MYP Process and reminded everyone that the MYP has been posted on the board website as well as on Upper Grand's social media accounts and updates will continue to be provided to the community and public.

- 1. Be it resolved, that OPSBA's Whole Child and Student Well-Being Priority, recognize the environmental determinants of mental health on student achievement and well-being, and that this be included in OPSBA advocacy work plans and activities.
- Be it resolved, that OPSBA's Whole Child and Student Well-Being, and Sustainable and Equitable Education Funding Priorities recognize the inequitable impact of climate change on Indigenous Peoples, young people and socially and economically disadvantaged populations, and advocate for local board efforts in addressing these inequities.
- 3. Be it resolved, that OPSBA's Sustainable and Equitable Education Funding Priority, advocate for dedicated Capital and Renewal funding targeted to reduce School Board Energy and Transportation Carbon emissions.

Trustee Busuttil shared that this really puts at the forefront, the priority of climate change in the actions and the work of the Ontario Public School Board Association, and she hopes that trustees will be able to support this.

Trustee Bailey thanked Trustee Busuttil for the work and research that went into the policy resolution created on the board's behalf, and has no hesitation supporting it. He did note that he would like to include language that would advocate for specific carbon neutral funding embedded in the resolutions.

Trustee Busuttil proposed the last motion be revised to include:

3. Be it resolved, that OPSBA's Sustainable and Equitable Education Funding Priority, advocate for dedicated **Carbon Neutral**, Capital and Renewal funding targeted to reduce School Board Energy and Transportation Carbon emissions.

Both parties agreed to the friendly amendment.

**RESOLUTION #22-119**: Trustee Busuttil moved that the three resolutions, the last one as amended, be approved by the Upper Grand DSB for submission to the Ontario Public School Board Association as a policy resolution.

The motion carried.

Trustee Busuttil returned to the Chair.

Trustee Lustgarten Evoy indicated trustees should have received their invitation to purchase tickets for the Inaugural Upper Grand Learning Foundation Gala on May 27, 2022. This is the first gala being held for the UGLF and limited tickets are being sold due to space. She hopes that each trustee chooses to purchase a couple of tickets and to come out and join in. Trustee Edwards expressed thanks and appreciation to Trustee Lustgarten Evoy for stepping in and helping the UGLF.

### 23. OPSBA Report

### Update from Central West Regional meeting

Current OPSBA Strategic Priorities were discussed and input was sought for any changes or additions. Information was shared regarding the upcoming elections. This information was previously shared with trustees in an email. Also discussed were advocacy actions that OPSBA is undertaking in the lead up to the provincial and municipal/school board elections. A discussion took place to brainstorm ideas for how best to share information between the Board of Directors and member boards. Updates were received from the work groups and Project Compass. The Upper Grand DSB Regional Board report was shared and was in the Board package.

### PPAN Scholarship

This is the final year for the Public Property Assessment Network Scholarship for a \$1000 award for a student graduating from high school.
