## 12. Monthly COVID-19 Update

Earlier today Ontario's Chief Medical Officer of health Dr. Kieran Moor said he is "strongly recommending" that Ontarians wear masks in all indoor public settings, due to the circulation of respiratory viruses and the pressure this is putting on the province's health care system.

Director Sovran advised Trustees that a message was sent out to all staff within the system, that Upper Grand DSB strongly recommends everyone to continue to follow public health's preventative measures to reduce the spread of respiratory illnesses in schools. This information was posted on the Upper Grand DSB website as well.

Executive Superintendent McDonald provided an update on two key areas: Promoting Healthy, Safe Environments, and Monitoring Absenteeism and Unfilled Jobs. Continued measures and messages supported by Public Health that are being communicated to schools are: recommended daily screening, staying home when sick, and wearing a mask when out in public for 10 days after isolating. Also, Upper Grand DSB continues to stress and educate staff and students on the importance of the same protective measures that have been so effective over the past couple of years. Upper Grand DSB will resume Daily School Absence reporting on the board website allowing staff to monitor absenteeism rates and transparently share this information with the public. Starting on November 21, 2022, the Upper Grand DSB will post absenteeism data daily, by school, from Monday to Friday on the Upper Grand DSB public website. The webpage will show the overall percentage of absenteeism in any given school and compare it to that particular school's September attendance baseline.
