Upper Grand District School Board Board Meeting Tuesday, November 29, 2022 Minutes

The regular monthly meeting of the Upper Grand District School Board was held virtually and in person on Tuesday, November 29, 2022, in the Board Room at 500 Victoria Road North, Guelph, starting at 7:00 p.m. All Trustees were present. Student Trustee Brooke Hartley was also in attendance.

1. Meeting Called to Order

Board Chair Mesenbrink presided and called the meeting to order.

4. Chair's Remarks

Trustee Mesenbrink asked that everyone take a silent moment to reflect with compassion and strength, to all those who have suffered loss in their personal lives, across all Upper Grand schools and in the community.

5. Director's Remarks

In response to the withdrawal of services from CUPE earlier this month, all Upper Grand schools remained opened during this time. Director Sovran expressed thanks to every person involved and all efforts that were made across the school system, for the students to continue with in-person learning.

Director of Education Sovran provided some highlights and good news items that took place in Upper Grand DSB during the month of November.

Student Trustee Recipient of Vimy Pilgrimage Award

John F. Ross CVI student and Upper Grand Student Trustee, Julia Elmslie, has been named a recipient of the Vimy Foundation's Vimy Pilgrimage Award. The Vimy Foundation created the award to recognize the actions of young people ages 14-17 who are dedicated to the betterment of society. According to the Vimy Foundation, "recipients demonstrate an outstanding commitment to volunteer work through positive contributions, notable deeds, or bravery that benefits their peers, school, community, province, or country." This November, Julia travelled to France and Belgium with a

group of 15 like-minded peers to represent Canada and explore the history of the First World War.

Westside SS Celebrates Annual Pink Day Fundraiser

Students and staff at Westside SS raised over \$15,000 with their annual Pink Day fundraiser in support of Breast Cancer Canada, a nearly 40 per cent increase from the amount raised last year. Westside's Pink Day fundraiser began back in 2004 when a staff member had been diagnosed with breast cancer. Pink Day at Westside has evolved into their largest spirit day of the year, where students and staff can engage through wearing pink and participating in fundraising activities and families are invited to the school's community pancake breakfast.

Wellington Heights SS Student Receives the Queen's Jubilee Medal

A student from Wellington Heights SS has received the Queen's Jubilee Medal for her bravery and thoughtfulness. On October 18, 2022, Tori, a Grade 12 Wellington Heights SS student, was at her home when a tragic car accident occurred on Highway 6 in front of her home causing both vehicles involved in the accident to burst into flames. Tori wasted no time, calling 911 for help while running to the burning vehicles. Acting quickly and bravely, Tori helped to pull an individual from their burning car and brought them to safety until emergency personnel arrived on the scene. Tori was awarded the Queen's Jubilee Medal on November 8, 2022, by Member of Parliament, John Nater. A small ceremony was held in the Wellington Heights SS front foyer with Tori and her family, local dignitaries, Trustee Chair, and friends from her Biology class.

- 11. Financial Reports
- a) 2021/2022 Audited Financial Statements

Executive Superintendent Regier presented an overview of the Audited Financial Statements for the Board, and the 2021/22 Audited Financial Statements for the Upper Grand District School Board Trust Funds. Key points were highlighted, and an in-depth overview of the Audit Financial Statements were provided for the year ending August 31, 2022.

Stacey Stahlman from KPMG reported on the Audit Findings for the year ending August 31, 2022. Ms. Stahlman reported no changes in accounting practices and policies and stated that no audit differences and no significant control deficiencies were identified.

Ms. Stahlman expressed thanks to the staff in the Finance and Management teams for their assistance with the 2021-22 audits.

12. Reports from Officials

a) Ontario Public School Board's Association (OPSBA), Interim Delegate

Trustee Mesenbrink shared that at the November 15, 2022 Inaugural meeting, the Board deferred several agenda matters, including external appointments to the next regular Board meeting in January 2023, to engage in a review and possible revision to By-Law 1. Trustee Mesenbrink recommended that formally appointing voting delegates to OPSBA while the Board reviews its By-Law 1 ensures Board representation should any OPSBA business occur between now and the Organizational meeting. Trustee MacNeil has been the Upper Grand DSB delegate to OPSBA since December 2021, and Trustee Mesenbrink is presently the Chair of the Board.

b) Regular Board Meeting – January 2023

Director of Education Sovran announced that the Board is currently engaged in a comprehensive review of the Board By-Law 1 including the structure of committees, the frequency of meetings, and the conduct of business at Board meetings. This work is expected to conclude by the end of December 2022. Director Sovran recommended scheduling the next Regular Board meeting from the regular 4th Tuesday of the month to Tuesday, January 17, 2023. This would provide a two-month period to conduct the review of Board By-Law 1, including a two-week break (December 22 - January 8) as outlined in the approved 2022-2023 Upper Grand DSB School Year Calendar. Director Sovran also added that scheduling a Regular Board meeting on January 17, 2023 would likely reduce the need to call a Special Board meeting to address pressing matters of the Board.

15. Trustee Questions and Reports

Trustees MacNeil and Mesenbrink attended the OPSBA Board of Directors Meeting held on November 27th, 2022. Trustee MacNeil received a meeting summary from OPSBA and informed that the report (with links) would be sent to the Trustees. Brief highlights were shared on the following: retiring Executive Director W.R. (Rusty) Hick; new OPSBA Director of Labour Relations Andrew Gold and new OPSBA Director of Program Policy Dr. Valerie Nielsen; Education Policy and Program Issues; Legislative Updates; Education Finance; Government Relations, Public Affairs and Communications; 2022 Municipal and school Board Elections; and Program Policy.

Trustee Edwards asked why a Dates of Future Meetings Report was not included on the agenda. Trustee Mesenbrink explained at the present moment, there is only the Regular Board meeting scheduled for January 17, 2023, and with the Board currently reviewing the Board's By-Law 1, there most likely would have been several changes to titles, names, and so forth. It was indicated that the Dates of Future Meetings report could be incorporated after the Board finishes a comprehensive review of By-Law 1.
