Background

The report "Refresh of International Baccalaureate (IB) Program in UGDSB" was presented and received at the June 4, 2024, Policy and Priorities Committee meeting. Following a discussion of the report, committee members moved:

- THAT staff be directed to provide more information on the IB Program, specifically alignment with all UGDSB policies including past board resolutions; and
- THAT staff be directed to undertake a further review of all students who applied, students who were accepted and not accepted including if they were previously an UGDSB student or out of district.

Additional Information

Destreaming


Effective September 2021, Ontario school boards were directed by the Ministry of Education to eliminate the practice of streaming students into different course offerings for Grade 9. At the request of the Board, the Ministry of Education reviewed the current practice of streaming students accepted into the IB program for Grade 9 Math, Grade 9 English and Grade 9 Geography. Ministry of Education staff noted that these course offerings do not adhere to the principles of destreaming, where students of mixed academic abilities and pathways learn together.

Student Application Analysis (Admission/Wait-list/Rejection)


Staff were directed to undertake a further review of all students who applied to the IB Diploma Program (IB DP) and identify students who were accepted and not accepted,

including if they were previously an UGDSB student or out of district. An explanation of each graph is provided with the corresponding graphs shown below.


The graph below represents the number of students who have applied and been accepted, as well as the number of students enrolled in IB each year for grades 9 to 12. The last few graphs in this chart are not completed, as these are current cohorts.




The next clustered graph represents the number of applications and acceptances from UGDSB students and non-UGDSB students over the span of the 7 cohorts. Non-UGDSB students are students not within the catchment area of UGDSB or not registered in one of our schools (e.g. application from private school or coterminous board).




This clustered bar graph below shows the number of applications and acceptances for Wellington County schools over the span of seven years. This graph, as well as the two following have the same scale so you can easily compare across different regions.




This graph shows the number of applications and acceptances for Dufferin County schools.




This graph shows the number of applications and acceptances for Guelph schools.




This clustered bar graph shows the number of applications and acceptances for school boards, private school, and international school students, over the span of seven years.



These graphs demonstrate a comparison over five years of students leaving the program prior to completing the IB DP. Students who identify as male, students with an Individual Education Plan (excluding students identified as gifted), and students from private schools or coterminous boards are more likely than their peers to leave IB at some point between entering in grade 9 and graduating from the IB DP. Due to a small sample size, students who identify as non-binary were removed from the gender comparison graph.



This chart reflects the origin school and percentage of students who leave IB programming between grade 9 and grade 12. GCVI is also included in this chart because there are students who enter IB while enrolled at GCVI, in their grade 10 or 11 school year.



Conclusion
